

FALL 2015 CARD CONTROLS SWEEPSTAKES OFFICIAL RULES

1. NO PURCHASE OR DOWNLOAD AND REGISTRATION OF CARD CONTROL APPLICATION NECESSARY TO ENTER OR WIN.
2. Sweepstakes open to lawful U.S. residents who are at least 18 years old at time of entry and have at least one consumer account at a participating financial institution (“Participating Institution”) prior to the Sweepstakes announcement date. For a list of Participating Institutions, [click here](#). The following individuals and their immediate family members (spouses, domestic partners, parents, children or siblings) are not eligible to enter: Employees of Ondot Systems, Inc., employees of CU Cooperative Systems, Inc. dba CO-OP Financial Services, and employees and compensated or volunteer officials of Participating Institutions. Residents of Florida and Rhode Island are not eligible.
3. Odds of winning depend on number of entries received.
4. One entry per person. Any attempt by a single person to obtain more than one entry will invalidate all entries by that person.
5. The Sponsor and Administrator of this Sweepstakes is Ondot Systems, Inc., 2680 North First Street, #200, San Jose, CA 95134 (“Sponsor”).
6. Enter automatically by downloading CardNav, completing registration, and setting a control on an Android or Apple mobile device.
7. To enter without downloading and registering a card control application, mail a 3” x 5” card with your name, address, daytime telephone number, e-mail address, name of your Participating Financial Institution, and last four digits of your consumer account number with Participating Financial Institution in a #10 legal size envelope to Ondot Systems, Inc., Fall 2015 Card Controls Sweepstakes, 2680 North First Street, #200, San Jose, CA 95134. All mailed entries must be postmarked no earlier than October 1, 2015, and no later than December 20, 2015. Metered mail entries will not be eligible.
8. Sponsor will not be responsible for lost, mis-delivered, damaged, incomplete or illegible mail entries or failed attempts to enter by downloading and registering a card-control application regardless of the reason for such failure.
9. No other entry methods permitted.
10. The Sweepstakes period opens at 12:01 a.m. Pacific Time on October 1, 2015, and ends at midnight Pacific Time on December 20, 2015.
11. The Sponsor will randomly select prize winners from among eligible entries on approximately January 20, 2016.

12. The potential winners will be notified by e-mail, mail or telephone. Except where prohibited, the winner must sign and return a Declaration of Compliance, Liability and Publicity Release (“Declaration”) within seven days after the Sponsor contacts or attempts to contact the potential winner. If the Sponsor is unable to contact the potential winner or does not receive the Declaration, the potential winner will forfeit the prize and an alternate winner will be chosen.
13. The Sponsor’s decisions regarding administration of the Sweepstakes, determination of eligibility of entries and selection and verification of winners will be final. If an ineligible entry is drawn, the Sponsor will draw an alternate entry.
14. All Entries: One Grand Prize of \$5,000 cash will be awarded. In addition, four runner-up prizes of \$500 cash each will be awarded.
15. CardNav Entries: One cash prize of \$500 will be awarded to a person whose card control application registration or mailed entry reflects an account at a Participating Institution that uses CO-OP Financial Services’ CardNav application.
16. Prizes are non-transferrable. An alternate prize of equal or greater value may be substituted if an announced prize is unavailable for any reason.

18. Taxes on prizes, if any, are the winner’s sole responsibility.

By entering the contest, the entrant agrees to indemnify, defend and hold Sponsor, CO-OP Financial Services, their Participating Financial Institution, and their respective officers, directors, employees, advertising agencies and prize suppliers harmless from any claim, injury, loss, or damage to any person or property that results from the acceptance or use of any prize.
20. This Sweepstakes is subject to all applicable federal, state and local laws and regulations. Void where prohibited.
21. By entering the Sweepstakes, the entrant agrees to these Official Rules.
22. By entering the Sweepstakes and accepting a prize, the entrant consents to the use of his or her name, likeness and hometown in promotional materials of Ondot and his or her Participating Institution.
23. Sponsor reserves the right to cancel, suspend or modify the Sweepstakes if in Sponsor’s judgment the integrity of the Sweepstakes is impaired. If this occurs, Sponsor may elect to hold a random drawing from among eligible entries received to the date of suspension of the Sweepstakes. Sponsor may seek damages and/or criminal prosecution of any person who attempts to interfere with the legitimate operation of the Sweepstakes.

Entrant agrees that (a) jurisdiction and venue for any dispute arising out of or related to the Sweepstakes will take place in a state or federal court of competent jurisdiction in San Jose, California, and (b) damages recoverable, if any, will be limited to costs associated with entering the Sweepstakes, and entrant waives any right to indirect, punitive, incidental or consequential damages. Each party will bear its own attorneys' fees in pursuing any claims or disputes arising out of the Sweepstakes.
